

IN A WORLD WHERE MORE THAN 39 MILLION PEOPLE ARE TOTALLY BLIND, EIGHT OUT OF TEN ARE FROM CAUSES THAT COULD HAVE BEEN PREVENTED, TREATED OR CURED. IN ADDITION, MORE THAN 246 MILLION CHILDREN AND ADULTS HAVE LOW VISION. IN MYANMAR, HKI'S TECHNICAL ASSISTANCE TO PHYSICIANS AND CLINICS LED TO APPROXIMATELY 33,000 CATARACT SURGERIES BEING PERFORMED ON PERSONS SUFFERING FROM THIS DEBILITATING CONDITION.
